



# Driving Directions

## ***From: Hwy 10 (Becker, Elk River, Anoka, Coon Rapids)***

Hwy. 10 N. to S. Benton Dr. (County Road 33) (Sauk Rapids) Exit. Make a left at overpass. Follow S. Benton Drive (County Road 33). You will be able to see the Budweiser Sign in the trees to the left). Drive past Budweiser and Trailer Court. You will see Great Northern Unclaimed Freight on your left and a long industrial style mall on the right (which is part of our Business Park). Make a right turn by the Benton Business Park sign. Make a right turn into the parking lot between buildings and go to the left. You will see a monument sign that says 800 Benton Business Park. We are the second business in that building. Our neighbors are Tri-County Insurance and All State Communications. Look for our large sign on the building.

## ***From: Hwy 10 (Rice, Royalton, Little Falls, Brainerd)***

Hwy. 10 S. to S. Benton Dr. (County Road 33) (Sauk Rapids) Exit. Make a right at the off ramp (you will see Budweiser to your right). Follow S. Benton Drive (County Road 33). Drive past Budweiser and Trailer Court. You will see Great Northern Unclaimed Freight on your left and a long industrial style mall on the right (which is part of our Business Park). Make a right turn between the Benton Business Park and Excel Optical signs (Industrial Dr. S.). Make a right turn into the parking lot between buildings and go to the left. You will see a monument sign that says 800 Benton Business Park. We are the second business in that building. Our neighbors are Tri-County Insurance and All State Communications. Look for our large sign on the building.

## ***From: Interstate I-94 S. (Cut Across to Hwy 10.) (Hwy 10 Directions)***

Take Left at Clearwater Exit (Hwy 25). Follow to Hwy 10. Take left on Hwy 10 at stop light. Follow Hwy. 10 N. to S. Benton Dr. (County Road 33) (Sauk Rapids) Exit. Make a left at overpass. Follow S. Benton Drive (County Road 33). You will be able to see the Budweiser Sign in the trees to the left). Drive past Budweiser and Trailer Court. You will see Great Northern Unclaimed Freight on your left and a long industrial style mall on the right (which is part of our Business Park). Make a right turn by the Benton Business Park sign. Make a right turn into the parking lot between buildings and go to the left. You will see a monument sign that says 800 Benton Business Park. We are the second business in that building. ## ***From: Interstate I-94 N. (1st St. Cloud Exit) (County Road 75, Division St. & Hwy 15)***

Merge left (County Road 75) at Bypass. Follow County Rd 75 which turns into Division St. in Waite Park. Take Left at Hwy 15 Stop lights. Follow Hwy. 15 North 4.2 Miles to (Sauk Rapids) (County Road 33) N. Benton Dr. Turn right off of over pass. Turn Left at under pass (1st stop light) and follow N. Benton Dr. about 3 miles through downtown Sauk Rapids, Past the New Bridge (old location)(2nd Stoplight). Follow North Benton Drive south which turns into South Benton Drive after Coborn's Superstore (3rd Stoplight). You will go through a total of 5 stop lights from the exit of Hwy 15. At the 5th stoplight you will see Bubba's Bar on your left and a large red building called Great Northern Unclaimed Freight on your right. Make a left turn between the Excel Optical and Benton Business Park signs. Across from Unclaimed Freight. Make a right turn into the parking lot between buildings and go to the left. You will see a monument sign that says 800 Benton Business Park. We are the second business in that building. Our neighbors are Tri-County Insurance and All State Communications. Look for our large sign on the building.

## ***From Hwy 15 (2nd Street S. Division Street, Crossroads Mall, Etc.):***

Turn right off of over pass. Turn Left at under pass (1st stop light) and follow N. Benton Dr. about 3 miles through downtown Sauk Rapids, Past the New Bridge (old location)(2nd Stoplight). Follow North Benton Drive south which turns into South Benton Drive after Coborn's Superstore (3rd Stoplight). You will go through a total of 5 stop lights from the exit of Hwy 15. At the 5th stoplight you will see Bubba's Bar on your left and a large red building called Great Northern Unclaimed Freight on your right. Make a left turn between the Excel Optical and Benton Business Park signs. Across from Unclaimed Freight. Make a right turn into the parking lot between buildings and go to the left. You will see a monument sign that says 800 Benton Business Park. We are the second business in that building. Our neighbors are Tri-County Insurance and All State Communications. ## ***From St. Cloud State University Area***

From the 9th Ave. & 10th St. S. Intersection. Follow 9th Ave. 2.4 miles through Downtown St. Cloud towards Sauk Rapids. Follow 9th Ave. .7 miles beyond intersection of Northway Drive across the Mississippi River Bridge (after new bridge road will turn into 2nd St. N.) (Sauk Rapids). Turn right at traffic light and follow S. Benton Dr. towards HWY 10. You will go through 3 more stoplights. At the 3rd stoplight you will see Bubba's Bar on your left and a large red building called Great Northern Unclaimed Freight on your right. Make a left turn between the Excel Optical and Benton Business Park signs. Across from Unclaimed Freight. Make a right turn into the parking lot between buildings and go to the left. You will see a monument sign that says 800 Benton Business Park. We are the second business in that building. Our neighbors are Tri-County Insurance and All State Communications. Look for our large sign on the building.
